

PRIVACY STATEMENT



Rent a Holiday Home, brand of "Huur een Huisje", takes your privacy very seriously and will process and use your data in a secure manner. This is the Privacy Policy of Rent a Holiday Home. We advise you to read carefully this Privacy Policy.

1. Who is Rent a Holiday Home

Rent a Holiday Home collects personal data of tenants, landlords and holiday homes. This "Personal data" are used to contacting potential tenants and landlords, where information can be exchanged and / or reservations can be made. Rent a Holiday Home is located in Hoorn and is registered with the Chamber of Commerce under number 73545619. The method of saving your Personal Information is registered with the Dutch Data Protection Authority.

2. What information is collected and processed by a Rent a Holiday Home?

In order to use the Service of Rent a Holiday Home, you can create a personal profile (My account). When creating this personal profile you must fill in some personal data. After you have entered these details, a profile is created automatically. This profile contains the information that you provided when you created the personal profile.

3. Automatically generated information

Rent a Holiday Home also collects automatically generated information about your surfing behavior during your use of the Service. This information includes your IP address (the number of your computer / mobile device that makes it possible to identify your computer), the date of filling in the Personal Data and "cookies." This information is always anonymous.

4. What are cookies and how does Rent a Holiday Home use these?

In order to offer the Service, Rent a Holiday Home uses cookies that are stored by your browser on your computer. Cookies are small pieces of information that our server sends to your browser with the intention that this information at your next visit will be sent back to our server. These small text files are stored on disk or in memory of your computer. Cookies cannot damage your computer or the files stored on your computer.

The cookies are stored information (such as the settings on your PC or mobile device, preferences indicated by you and the tips and discussions you are subscribed) for facilitating a subsequent use of the Service. This information contains your IP address, no name or address or other personal data.

You can set your browser to reject cookies during your next use of the Service. In that case it may happen that you cannot use all the features of the Service or you do not have access to (parts of) the Service. To learn more about these functions, you can consult your browser instructions or help function of your browser. If you want to make use

of cookies, make sure you log out before leaving a public computer.

5. For what purpose will use Rent a Holiday Home information about you?

Rent a Holiday Home will use information about you for the following purposes:

- to provide the best possible service to you;
- to send information on the services of Rent a Holiday Home;
- to set up anonymous statistical data and to make the Service;
- to provide your information to third parties on the basis of legal obligations;
- in order to adapt and improve service.

6. Use data Site Visits

Rent a Holiday Home uses automatically generated data for statistical purposes, including for security and improvement of its Website and the Service. Rent a Holiday Home provides a central website / marketplace where tenants and landlord of holiday come together. If you inquire for or do bookings on a holiday home, Rent a Holiday Home shares your personal data with the respective landlord.

7. Storage period

We keep your data as long as necessary for the aforementioned purposes or to comply with legal (storage) obligations. After the end of the retention period, we will delete or anonymize your personal data. You will of course no longer receive information from Rent a Holiday Home about new houses or other interesting mailings.

8. Use by third parties

Without your permission Rent a Holiday Home will not provide your Personal Information to third parties for direct marketing purposes (e.g. for sending advertising). Rent a Holiday Home may provide your information to third parties if this is necessary to provide the service to you and / or where such data cannot be linked to you personally (such as automatically generated information, other than your IP address). Finally, Rent a Holiday Home can provide your information to third parties if this is required on the basis of legal provisions, it is compelled to do so because of a lawsuit and / or where it considers it necessary to protect its own rights.

Rent a Holiday Home points out that landlords can make use of your Personal knowledge that you yourself have passed through the public section of the Web site. The data placed by the landlord on the Website may be indexed by external Web sites, such as search engines. Rent a Holiday Home does not control and is not responsible for how and if these third parties will treat your personal data with care.

9. Google Analytics

This website uses Google Analytics, a web analytics service provided by Google Inc. ("Google"). Google Analytics uses cookies to help

the website analyze how users use the site. The information generated by the cookie about your use of the Website (including your IP address) will be transmitted to and stored by Google on servers in the United States. Google uses this information to track how you use the Website, to prepare reports on the Website activities to offer for website operators and providing other services relating to website activity and internet usage. Google may also transfer this information to third parties if Google is legally required, or where such third parties process the information on Google's behalf. Google will not associate your IP address with other data held by Google. You may refuse the use of cookies by selecting the appropriate settings on your browser. However, Rent a Holiday Home points out that in that case you may not be able to use all features of this website. By using this Website, you consent to the processing of data by Google in the manner and for the purposes set out above.

10. Surveys, opinion and assessment tests

It is possible that Rent a Holiday Home is doing a survey among its users to measure and / or improve a particular service or quality of its products. Participation in such research is anonymous and voluntary. After processing the data, any personal information associated to the survey will be destroyed.

11. How Rent a Holiday Home protects your Personal Information?

Rent a Holiday Home has taken appropriate technical and organizational measures to secure the personal data against unauthorized or otherwise undesired access. For you this is visible through the lock that appears in your browser when you visit the site. Employees of Rent a Holiday Home or third parties engaged by Rent a Holiday Home will also only have access to the personal data that are necessary for the performance of their duties. Furthermore, we recommend that you choose the most secure password possible when creating your account, keep it secret and renew it regularly. Your password will be stored encrypted. We regularly test our website with automated security scans and take adequate measures to protect our systems against unauthorized access.

Rent a Holiday Home will not keep the Personal Data longer than necessary.

Rent a Holiday Home has an DTA (Development, Test, Acceptance) environment in which all new functionalities are developed, tested and accepted. These environments are copies of the Rent a Holiday Home website to test the new functionalities. All personal information in the DTA environments is completely anonymous.

Rent a Holiday Home cannot guarantee that unauthorized third parties will never circumvent the measures taken by Rent a Holiday Home and will use your Personal Data for improper

purposes. In addition, Rent a Holiday Home will also point out that the Content made public by you with the help of the Service can be viewed and used by third parties. Rent a Holiday Home cannot guarantee that these third parties will never use your Personal Data for improper purposes.

12. Transfer outside the EU

As far as personal data are passed on to third parties in accordance with this Privacy Statement and these third parties are established outside the European Union, such a transfer takes place only if that country ensures an adequate level of protection or if the transfer is necessary for the implementation of the agreement between you and Rent a Holiday Home or for taking steps in response to a request from you and that are necessary for the conclusion of an agreement.

By using the Service you give actively permission to transmit data outside the European Union.

13. Transfer Company

It is possible that one or more assets or parts of Rent a Holiday Home be transferred to a third party or that Rent a Holiday Home merges with a third party. In that case, your Personal Information may also be transferred.

14. Access to and correction of your Data

You can at any time see or correct your Personal Data. You will need to log in before you see your own profile. Any changes can be made there.

Regarding the Personal Data that cannot be found in your profile, such as IP address, you can freely and at reasonable intervals request Rent a Holiday Home to inform you how and what kind of Personal Data are processed. Rent a Holiday Home notifies you in writing within four weeks whether your Personal Data are processed. You can then request Rent a Holiday Home to correct, add to, delete, or block if they are factually incorrect, for the purpose or purposes of the processing incomplete or irrelevance or otherwise violative a legal provision to be processed. The request contains the changes. Rent a Holiday Home will inform you in writing within four weeks of receipt of the request whether or to what extent it complies with the request. A refusal must be given by reasons. A decision to correct, add, delete or block is executed as soon as possible.

On removal of Personal Data Rent a Holiday Home will only keep an anonymous copy of the data archive. As your Personal Data were also available to others using the service, Rent a Holiday Home is not able to remove your information from their systems. You will in that case have to request these third parties themselves to remove the data.

When you no longer or you want to receive information from Rent a Holiday Home or third parties, you can change your preferences by

logging into your profile (my account) and change your settings.

15. How far reaches the responsibility of Rent a Holiday Home?

This Privacy Policy only relates to personal data obtained via the Web Site of Rent a Holiday Home. The Website may also contain links to other websites. Rent a Holiday Home has no control over third party sites that are linked. It may therefore be that the use of these third party websites other privacy policy applies. Rent a Holiday Home therefore accepts no responsibility or liability for (the operation and / or content of) websites or third party services.

16. Can this Privacy Statement be modified?

This Privacy Statement may be modified. These changes will be announced on the Website.
